This register provides speech-language therapists with a list of Level 3-6 FEES SLTs across the country. This list is updated in July and December each year. Sign off at each level is managed according to sign off level (see NZSTA FEES Competency Framework). For the NZSTA registry, evidence must be sighted by the NZSTA. Evidence for sign off includes

- Certificate of competency (NZ level 5 sign off)
- Signed NZSTA/ local competency using NZSTA framework
- An email from the line manager SLT has competency without clear evidence but and has been signed off by a level 5 FEES trainer in NZ following audit

ADULT Level 3: Basic endoscopy for FEES (requires level 1 and level 2: FEES procedure direction & interpretation as prerequisites)

SLT may interpret and perform FEES assessment including endoscopy on non-complex patients (the register will specify if endoscopy is not included), with another FEES trained or training SLT or ORL.
